### NOTIFICATION

CONSTITUTION OF INDIA.

No. RB/TC/e-11019(16)(2014)/Notification-5/1122/2014.—Whereas, by Notification, No. RBTC/e-13013(4)/Notification-1/474/2014, dated the 9th June 2014 (hereinafter referred to as “the said Notification”), issued in exercise of the powers conferred by sub-paragraph (1) of Paragraph 5 of the Fifth Schedule to the Constitution of India, the Governor of Maharashtra, directed that, section 4 of the “Maharashtra State Public Services [Reservation for Scheduled Castes, Scheduled Tribes, De-Notified Tribes (Vimukta Jatis), Nomadic Tribes, Special Backward Category and Other Backward Classes] Act, 2001 (Mah. VIII of 2001) and any other Rules or Orders made in this regard, shall notwithstanding anything contained in any other law or rule or order for the time being in force in that regard, apply to the posts specified in the Appendix to the said Notification, subject to the modification that said such posts which are to be filled in by direct recruitment for the Scheduled Areas of the Districts which have Scheduled Areas, in the State of Maharashtra shall be filled in by the local Scheduled Tribe candidates only, having requisite qualification;

And whereas, it is expedient to issue similar directions in respect of the post of Kotwal under Revenue Department, which are to be filled in by direct recruitment for the Scheduled Areas of the Districts which have Scheduled Areas, in the State;

And whereas, it is expedient to further amend the said Notification for the said purpose and for certain other purposes;

Now, therefore, in exercise of the powers conferred by sub-paragraph (1) of paragraph 5 of the Fifth Schedule to the Constitution of India, the Governor of Maharashtra hereby amends the said Notification, as follows, namely:—

In the Appendix to the said Notification,—

(a) for entry 5, the following entry shall be substituted, namely:—

“ 5. Teacher ...

(i) Rural Development Department,

(ii) Tribal Development Department ”;

(b) for entry 9, the following entry shall be substituted, namely:—

“ 9. Auxiliary Nurse and Midwife (ANM) ....

Rural Development Department ”;

(c) for entry 10, the following entry shall be substituted, namely:—

“ 10. Multi-Purpose Health Worker (MPW) ....

(i) Rural Development Department,

(ii) Public Health Department ”;

(d) the following entry shall be added at the end, namely:—

“ 12. Kotwal .... Revenue and Forest Department ”.
